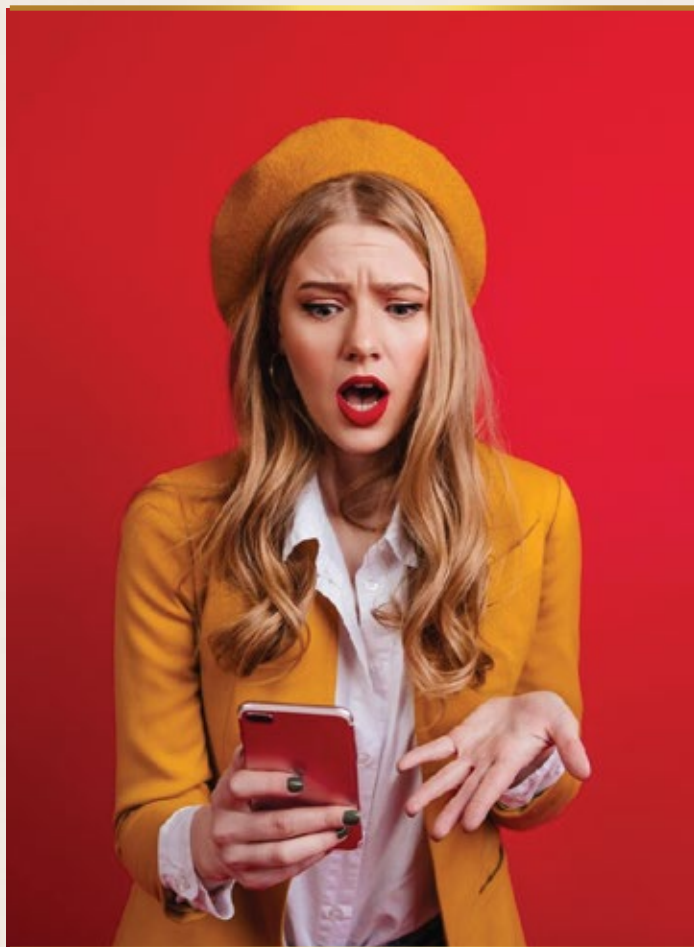

Negotiation can also make relationships more amicable.

9. High Rate Of Compliance & Agreement

Parties who have reached their own Agreement in Negotiation are also generally more likely to adhere with its terms than those whose resolution has been imposed by a Third Party Decision-Maker.

10. Mutually Satisfactory End Results
